The meeting will be held on Wednesday, January 31, 2024, at 1:15 p.m.


The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Public comments;
- 2. Review and approval of the minutes of the meeting of the Board of Directors held on December 18, 2023;
- 3. Bookkeeper's report, including financial and investment reports and the payment of invoices presented;
- 4. Amendment of operating budget for the District's fiscal year ending May 31, 2024;
- 5. Adopt Resolution Adopting List of Qualified Brokers Authorized to Engage in Investment Transactions with District;
- 6. Receive Tax Assessor-Collector report and approve payment of invoices presented and moving of accounts to uncollectible roll;
- 7. Report on legal action taken by the District's delinquent tax collections attorney, authorize foreclosure proceedings, installment agreements, and the filing of proofs of claim;
